

WATER SLIDE RULES

- 1) Only one rider at a time. Absolutely no chain riding, stopping, standing, kneeling, or diving.
- 2) All riders must ride feet first while lying on their back. Do not sit up while riding the slide.
- 3) All riders must be at least 48" tall and under 300 pounds.
- 4) Obey all rules given by staff personnel.
- 5) No foreign objects are allowed in pockets and no jewelry can be worn while riding the slide. No exposed zippers, buckles, rivets or metal ornamentation can be worn; only approved swim suits allowed. No Sunglasses.
- 6) No tubes, mats, or life jackets are permitted on the water slide.
- 7) WARNING: Water depth is 3'6".
- 8) The line shall form on the pool deck with one rider on the landing and one rider in the slide. Riders must wait for signal from staff personnel to start the ride.
- 9) Riders must be in good health. Elderly persons, those suffering from heart disease, high blood pressure, epilepsy, or persons using prescription medication should consult their physician before using the slide. Individuals with medical conditions including, but not limited to pregnancy, heart, or back problems should not ride the slide.

Do not discard your pool pass card . The same card is used when you renew your membership. A fee of \$5.00 will be charged for a lost pool pass card. Pool pass is Non-Transferable.

Proof of Residency: official documents with current address and all 3 proofs are required for membership.

- 1) Property tax bill or deed - must show section, block and lot number; or if renting a current lease.
- 2) Current utility bill– gas, electric, water, cable or telephone.
- 3) Driver’s license or Non-Driver’s ID.

The following proofs will **NOT** be accepted for membership:
Library Card; Check; Expired ID; Nassau County Leisure Pass; Passport; Town or Village ID Card.

Pass Renewal: must show **CURRENT UTILITY BILL & LICENSE**

RULES AND REGULATIONS GOVERNING THE USE OF THE PHYSICAL ACTIVITIES CENTER

14. The Rules and Regulations contained in Chapter 39 of the Code of the Town of North Hempstead which are applicable to the town parks and beaches are also applicable to Michael J. Tully Park and The Physical Activities Center.
15. Children five (5) years of age and older must utilize the locker room of their own gender. If the child needs assistance in dressing , family changing rooms are available.
16. Children who are not toilet trained must wear tight fitting rubber plastic pants over a clean cloth diaper. Little Swimmers disposable swim pants are permitted along with rubber pants and swim suit. All other types of diapers are prohibited. All changes must be done in designated areas
17. To use the sauna or steam room patrons must be 16 years of age or older. The Town of North Hempstead and the Nassau County Board of Health require proper attire when using the sauna and steam rooms. A bathing suit or towel coverage are required. No drying of clothes, no use of lotions, or fragrances, no exercising, or drying off in sauna and steam rooms. No tampering with heating units allowed.
18. To use the exercise room patrons must be 16 years of age or older. Proper exercise attire must be worn at all times– full tee shirt (no cut-offs, tank tops, or cap sleeves), warm-up suits, sweat pants, leotards, tights, or gym shorts are permitted. Proper footwear must be worn at all times-sneakers, sport shoes, cross training shoes, or ballet shoes. Street clothes, street shoes and bare feet are prohibited. All clothing and personal items must be placed in the area provided. No hanging clothes on exercise equipment. No instructors-Use of equipment is at your own risk.
19. Passes may be revoked or entrance into the facility denied for failure to comply with sanitary and safety rules.
20. Office personnel, lifeguards and attendants are required to enforce and maintain all rules and regulations for your safety. Failure to comply will result in suspension of pass or entry into the facility denied.

RULES AND REGULATIONS GOVERNING THE USE OF THE PHYSICAL ACTIVITIES CENTER

1. No admission to the Physical Activities Center without a pool membership card or proper identification and payment of designed fees.
2. No child twelve (12) years of age or younger shall be admitted to the pool area unless accompanied by a member of his/her family sixteen (16) years of age or older, or an adult eighteen (18) years of age or older.
3. Persons fifteen (15) years of age or younger must leave the pool area by 6:00 pm, unless accompanied by an adult. Only one adult per 5 children at all times is permitted
4. No one is permitted on the pool deck area, except in a swim suit. Street clothes, shoes, sandals, are not permitted. Aqua shoes are allowed. All bathers are required to take showers before entering the pool.
5. Smoking is prohibited in the entire building.
6. No Diving at all times.
7. No person shall use the pool or water slide that, in the opinion of the lifeguard in charge is not capable due to age, skill, or physical condition.
8. No person shall use the pool that, in the opinion of the lifeguard in charge is unsafe to bathe or swim. Conditions are safe only when the lifeguards are on duty.
9. The following are strictly prohibited in the pool area: ball playing of any kind, pushing, running, dunking, boisterous conduct, toys, play equipment, strollers, carts, food, beverages, candy, glass containers and suntan lotions. No card games, radios, cd players, stereos or musical instruments are permitted. Flotation devices (swim fins, mask, snorkels) are also prohibited. Portable devices with headphones are permitted. The use of cell phones or camera phones of any kind are not permitted on the pool deck, pool balcony and locker rooms.
10. Pool furniture shall not be moved or reserved.
11. Dressing or undressing is permitted in designated areas only.
12. The Town Board shall set forth the rules and regulations as are necessary for the safety and welfare of the public. The Commissioner of Parks and Recreation may adopt additional rules and regulations that are found to be in the public interest and necessary for the safety, welfare and protection of the public.
13. The supervisor of the pool may designate the maximum number of persons admitted in the pool enclosure consistent with public safety guidelines. The maximum number permitted in the pool and pool enclosure shall be posted in the pool area for the convenience of the patrons.

Locker Fee: There are \$.10, \$.25, and \$.50 cents lockers available with keys. There are no refunds of coins lost in lockers. A fee of \$15.00 is required for a lost locker key. Not responsible for lost items.
