<b>November 10, 2015</b>	<b>Last day to pay School Tax without penalty</b>
<b>January 1, 2016</b>	<b>First-half 2016 General Tax due</b>
<b>February 10, 2016</b>	<b>Last day to pay General Tax without penalty</b>
<b>April 1, 2016</b>	<b>Second-half 2015-2016 School Tax due</b>
<b>May 10, 2016</b>	<b>Last day to pay School Tax without penalty</b>
<b>July 1, 2016</b>	<b>Second-half 2016 General Tax due</b>
<b>August 10, 2016</b>	<b>Last day to pay General Tax without penalty</b>

*When the 10th falls on a weekend or holiday, the last day to pay without penalty is the following business day.  
Note: The Tax Office will be closed in 2015 on October 12, November 3, November 11, November 26, and December 25.  
We will also be closed in 2016 on January 1, January 18, February 12, February 15, May 30, July 4, September 5,  
October 10, November 8, November 11, November 24, and December 26.*
