This amendment is being issued to answer questions concerning the RFP:

1. Regarding Page 6, Paragraph 4(c): When we last saw the three (3) snack bar facilities which are the subject of this RFP, all of them had operational and functioning running hot and cold water and operational drains/sewer connection pipes and fixtures. Are these three (3) snack bars still so equipped?

Answer: Yes.

2. Are the Ansul/exhaust and fire suppression systems up to date?

Answer: Yes. The majority of the systems are up to date. The Town is working towards keeping all systems compliant with fire code.

3. Is the Town responsible for the service/maintenance of the Ansul fire suppression systems?

Answer: Yes

4. We request the opportunity to visit each concession/snack bar location.

Please advise when 5 walk-throughs can be conducted.

5. Did the 2014 vendor opt out of his contract, or did the town terminate the contract?

Answer: The Town has the option to extend the current agreement. However, the Town finds it more prudent to solicit proposals rather than simply extend the current agreement.

6. What was the reported volume for the 2014 season by location?

Answer: The Town does not have the final volume information for 2014

7. What are the previous fees paid to the town for the concessions?

8. **Answer: The Town was entitled to payments totaling \$21,175 for 2014**

9. Are the sales figures that are required to be submitted available from previous seasons ?

10. Have any contractors defaulted on the contracts in the 5 years ?

Answer: The Town is not prepared to discuss experiences with previous contractors.
