**PROPOSED RESOLUTION**

**\*\*\*\*offered the following resolution and moved its adoption, which resolution was declared adopted after a poll of the members of this Board:**

**RESOLUTION NO. s12 -2017**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT FOR MANAGEMENT AND MAINTENANCE OF LANDFILL GAS COLLECTION AND CONTROL SYSTEMS AT THE L4 AND L5 LANDFILLS IN PORT WASHINGTON, NEW YORK.**

**WHEREAS**, the Town of North Hempstead Solid Waste Management Authority (the "Authority") requires the management and maintenance of the landfill gas collection and control system at the L4 and L5 Landfills in Port Washington (the "Services"); and

**WHEREAS**, after reviewing proposals received in response to to a Request for Proposals (the "RFP") issued by the Authority, the Executive Director of the Authority has recommended that this Board authorize the execution of an agreement with Wehran LFG Services LLC (the "Consultant") to perform the Services commencing upon execution of an agreement for the Services and ending December 31, 2021 in consideration of the fees proposed in the Consultant's proposal (the "Agreement"); and

**WHEREAS**, the RFP had requested alternative pricing proposals for various services listed in the RFP to address needs of the Authority over the term of the Agreement; and

**WHEREAS**, this Board wishes to authorize the execution of the Agreement and to provide the Executive Director of the Authority with authorization, over the term of the Agreement, to apply the alternative price proposal that best meets the needs of the Authority.

**NOW, THEREFORE, BE IT**

**RESOLVED** that the Chair of the Board be and hereby is authorized to execute the Agreement and to take such actions necessary to effectuate the foregoing; and be it further

**RESOLVED** that the Executive Director of the Authority shall have the authorization, over the term of the Agreement, to apply the alternative price proposal that best meets the needs of the Authority; and be it further

**RESOLVED** that the Office of the Town Attorney, as counsel to the Authority, be and hereby is authorized and directed to supervise the negotiation and execution of the Agreement and to take such further actions as may be necessary to effectuate the foregoing; and be it further

**RESOLVED** that the Assistant Treasurer be and hereby is authorized and directed to pay the costs of the Agreement upon receipt of duly executed Agreement and certified claims therefor.
