PLEASE TAKE NOTICE that the Annual Election of the New Hyde Park Fire District will take place on Tuesday, December 13, 2016 between the hours of 1:00 pm and 9:00 pm at the Fire Headquarters Building located at 1555 Jericho Turnpike, New Hyde Park, New York, for the purpose of electing one (1) Commissioner for a five (5) year term, commencing January 1, 2017 and ending December 31, 2021. Registered voters residing in the New Hyde Park Fire District shall be eligible to vote. Residents must be registered to vote with the Nassau County Board of Elections twenty-three (23) days before December 13, 2016 in order to be eligible to vote.

PLEASE TAKE FURTHER NOTICE, that Candidates for District office shall file their names in petition form with the Secretary of the New Hyde Park Fire District at the Fire District Office located at 1555 Jericho Turnpike, New Hyde Park, New York, weekdays between the hours of 10:00 AM and 5:30 PM, and not later than 5:30 PM, November 23, 2016. To be eligible a candidate must submit petitions sworn to by at least twenty-five (25) resident electors of the New Hyde Park Fire District.

Candidates shall procure petition forms from the Fire District Secretary

The Fire District Secretary shall prepare the ballot for the election (printed form for election machine) specifying the names of the candidates duly filed for each office in accordance with the above procedure, and in addition providing for a blank space for each office which may be filled in at the time of the election.

The adoption of the foregoing resolution was duly put to a vote and upon roll call the resolution was declared duly adopted.
