

**NOTICE OF HEARING**

**PLEASE TAKE NOTICE** that a public hearing will be held by the Town Board of the Town of North Hempstead in the Town Hall, 220 Plandome Road, Manhasset, New York, on the 23<sup>rd</sup> day of August, 2011, at 7:30 o'clock in the evening for the purpose of considering the rescission of the following ordinance:

- 1. T.O. 82-1963 (IN PART)**  
Adopted November 26, 1963  
**ALLENWOOD ROAD – SOUTH SIDE – NO STOPPING –**  
Starting from the east curb line of MIDDLE NECK ROAD east to a point opposite the west curb line of DAY COURT.
- 2. T.O. 88-1965**  
November 30, 1965  
**ALLENWOOD ROAD – SOUTH SIDE – NO TRUCKS OVER 4 TONS GROSS**  
From MIDDLE NECK ROAD east to PLYMOUTH ROAD then south to Oxford Boulevard.

**And be it further**

**RESOLVED** that at the same time and at the same place, the following ordinance be considered for adoption:

**GREAT NECK, NEW YORK**

**Section 1. All motor or other vehicles of any kind shall comply with the following regulation:**

- 1. ALLENWOOD ROAD – SOUTH SIDE – NO STOPPING HERE TO CORNER**  
From the east curb line of Middle Neck Road, east, for a distance of 50 feet.
- 2. ALLENWOOD ROAD – SOUTH SIDE – NO COMMERCIAL TRAFFIC EXCEPT LOCAL RESIDENTIAL DELIVERY –**  
From a point 19 feet east of a point opposite the west curb line of Day Court.
- 3. ALLENWOOD ROAD – NORTH SIDE – NO COMMERCIAL TRAFFIC EXCEPT LOCAL RESIDENTIAL DELIVERY –**  
From a point 12 feet east of the east curb line of Day Court (facing eastbound traffic).

**Section 2. All ordinances or regulations heretofore adopted in conflict with this ordinance are hereby repealed.**

**Section 3. PENALTIES: A violation of this ordinance shall be punishable by a fine not in excess of Thirty (\$30.00) Dollars, plus any surcharge payable to other governmental entities.**

**Section 4. This ordinance shall take effect ten days from the date of its publication and posting pursuant to Section 133 of the Town Law of the State of New York.**

**Section 5. This ordinance shall be incorporated in the Uniform Traffic Code of the Town of North Hempstead.**
