

## NOTICE OF HEARING

PLEASE TAKE NOTICE that a public hearing will be held by the Town Board of the Town of North Hempstead in the Town Hall, 220 Plandome Road, Manhasset, New York, on the 6<sup>th</sup> day of March, 2012, at 7:30 o'clock in the evening for the purpose of considering the rescission of the following ordinance:

Adopted October 17, 1973  
MC GREGOR AVENUE – NORTH SIDE – NO STOPPING HERE TO CORNER –  
From the west curbline of Mineola Avenue, west for a distance of 30 feet.
  
2. T.O. 52-1973 (IN PART)  
Adopted October 17, 1973  
MC GREGOR AVENUE – SOUTH SIDE – NO STOPPING HERE TO CORNER –  
From the west curbline of Mineola Avenue, west for a distance of 30 feet.

And be it further

RESOLVED that at the same time and at the same place, the following ordinance be considered for adoption:

### ROSLYN HEIGHTS, NEW YORK

Section 1. All motor or other vehicles of any kind shall comply with the following regulation:

1. MAC GREGOR AVENUE – GARFIELD PLACE – FULL STOP –  
All traffic westbound on Mac Gregor Avenue shall come to a Full Stop at its intersection with Garfield Place.
  
2. MAC GREGOR AVENUE – GARFIELD PLACE – FULL STOP –  
All traffic eastbound on Mac Gregor Avenue shall come to a Full Stop at its intersection with Garfield Place.
  
3. MAC GREGOR AVENUE – NORTH SIDE – NO STOPPING HERE TO CORNER –  
From the west curb line of Mineola Avenue, west, for a distance of 39 feet.
  
4. MAC GREGOR AVENUE – SOUTH SIDE – NO STOPPING HERE TO CORNER –  
From the west curb line of Mineola Avenue, west, for a distance of 55 feet.

Section 2. All ordinances or regulations heretofore adopted in conflict with this ordinance are hereby repealed.

Section 3. PENALTIES: A violation of this ordinance shall be punishable by a fine not in excess of Thirty (\$30.00) Dollars, plus any surcharge payable to other governmental entities.

**Section 4. This ordinance shall take effect ten days from the date of its publication and posting pursuant to Section 133 of the Town Law of the State of New York.**

**Section 5. This ordinance shall be incorporated in the Uniform Traffic Code of the Town of North Hempstead.**
