

NOTICE OF HEARING

PLEASE TAKE NOTICE that a public hearing will be held by the Town Board of the Town of North Hempstead in the Town Hall, 220 Plandome Road, Manhasset, New York, on the 19th day of June, 2012, at 7:30 o'clock in the evening for the purpose of considering the rescission of the following ordinance:

1. **T.O. 48-1987 (IN PART)**
Adopted September 15, 1987
MAIN STREET EXTENSION – NORTH SIDE – 15 MINUTE PARKING –
From a point 30 feet east of the east curbline of Port Washington Boulevard, east for a distance of 45 feet.

2. **T.O. 48-1987 (IN PART)**
Adopted September 15, 1987
MAIN STREET EXTENSION – NORTH SIDE – 15 MINUTE PARKING –
From a point 110 feet east of the east curbline of Port Washington Boulevard, east for a distance of 37 feet.

3. **T.O. 48-1987**
Adopted September 15, 1987
MAIN STREET EXTENSION – NORTH SIDE – NO STOPPING ANYTIME –
From a point 147 feet east of the east curbline of port Washington Boulevard, east for a distance of 50 feet.

And be it further

RESOLVED that at the same time and at the same place, the following ordinance be considered for adoption:

PORT WASHINGTON, NEW YORK

Section 1. All motor or other vehicles of any kind shall comply with the following regulation:

1. **LUESTER T. MERTZ PLAZA – NORTH SIDE – 15 MINUTE PARKING –**
From a point 30 feet east of the east curb line of Port Washington Boulevard, east, for a distance of 100 feet.

2. **LUESTER T. MERTZ PLAZA – NORTH SIDE – NO STOPPING ANY TIME –**
From a point 130 feet east of the east curb line of Port Washington Boulevard, east, for a distance of 10 feet.

3. **LUESTER T. MERTZ PLAZA – NORTH SIDE – NO STOPPING ANY TIME –**
From a point 165 feet east of the east curb line of Port Washington Boulevard, east, for a distance of 40 feet (which is at its terminus).

4. **LUESTER T. MERTZ PLAZA – NORTH SIDE – DO NOT ENTER –**
All traffic eastbound on LuEster T. Mertz Plaza shall not enter the egress driveway of the Port Washington Post Office parking lot, which is at a point 205 feet east of the east curb line of Port Washington Boulevard.
5. **PORT COMMONS SHOPPING CENTER PARKING LOT DRIVEWAY – LUESTER T. MERTZ PLAZA – FULL STOP –**
All traffic egressing the Port Commons Shopping Center parking lot driveway, approximately 211 feet east of the east curb line of Port Washington Boulevard, shall come to a Full Stop at its intersection with LuEster T. Mertz Plaza.
6. **PORT COMMONS SHOPPING CENTER – TOWN OF NORTH HEMPSTEAD PARKING LOT – EAST SIDE – NO PARKING ANY TIME –**
From a point 35 feet south of the south curb line of LuEster T. Mertz Plaza, south, for a distance of 8 feet.
7. **PORT COMMONS SHOPPING CENTER – TOWN OF NORTH HEMPSTEAD PARKING LOT – EAST SIDE – 15 MINUTE PARKING –**
From a point 43 feet south of the south curb line of LuEster T. Mertz Plaza, south, for a distance of 135 feet.

Section 2. All ordinances or regulations heretofore adopted in conflict with this ordinance are hereby repealed.

Section 3. PENALTIES: A violation of this ordinance shall be punishable by a fine not in excess of Thirty (\$30.00) Dollars, plus any surcharge payable to other governmental entities.

Section 4. This ordinance shall take effect ten days from the date of its publication and posting pursuant to Section 133 of the Town Law of the State of New York.

Section 5. This ordinance shall be incorporated in the Uniform Traffic Code of the Town of North Hempstead.
