Mooring Season 2016

Dear North Hempstead Boater:

We apologize again for the delay in getting the mooring application out, and hope this hasn't been an inconvenience to you. Due to the delay in sending out the applications there will not be a late fee this year.

Permits will only be issued for boats 26' and under. If your boat is larger than 26', please contact us and we can direct you to the deep draft moorings. **Existing customers may NOT upgrade to OVER 26'!!**

THE FEE FOR 2016 MOORING PERMITS IS REMAINING AT \$435.00 WHICH INCLUDES THE WATER TAXI SERVICE.

The hours of operation for the water taxi service are indicated on the attached sheet.

The guidelines detailed below **MUST** be followed in order to process your application:

- **Application must be completely filled out and SIGNED.**
- **Enclose a copy of your driver's license and boat registration. Be sure that your boat registration is current and not expired! Applications submitted without a registration WILL NOT be considered for a 2016 spot.**
- Checks payable to Town of North Hempstead.
- Payment may be made by credit card (Master Card or Visa). Credit card information should be indicated in the space provided on the mooring application.
- No cash will be accepted as payment
- NO REFUNDS


If you have complied with all of the regulations and have removed your ground tackle by **November 1, 2015**, you may then be considered for a 2016 mooring space.
