

Supervisor Bosworth offered the following resolution and moved its adoption, which resolution was declared adopted after a poll of the members of this Board:

RESOLUTION NO.545-2015

A RESOLUTION AUTHORIZING THE AWARD OF A BID FOR THE REPLACEMENT OF UNDERGROUND STORAGE TANKS AT THE DEPARTMENT OF PUBLIC WORKS FACILITY, 285 DENTON AVE., NEW HYDE PARK, NEW YORK, DPW PROJECT NO. 13-01.

WHEREAS, the Town Clerk solicited bids for the replacement of underground storage tanks at the Department of Public Works Facility, 285 Denton Avenue, New Hyde Park, New York, DPW Project No. 13-01 (the “Project”); and

WHEREAS, bids in response to the solicitation (the “Bids”) were received and were opened, which Bids are as follows; and

WHEREAS, after an initial review of the bids, the apparent low bidder, Aventura Corp., (“Aventura”) was found to not have in place an apprenticeship training agreement approved by and registered with the Commissioner of the New York State Department of Labor appropriate for the trade “Plumber – Pump and Tank” or “Plumber” and, as such, was not compliant with Town regulations requiring such agreements; and

WHEREAS, Aventura was found to not be in compliance with the Town’s apprenticeship training agreement requirements, the Commissioner of Public Works (the “Commissioner”) has recommended that Aventura’s bid be rejected; and

WHEREAS, the Commissioner has contacted the bidder submitting the second lowest bid, Island Pump & Tank Corp., 40 Doyle Court, East Northport, New York 11731 (the “Contractor”), to discuss modifying its bid so as to decrease the amount to be paid by the Town for the completion of the Project;

and

WHEREAS, the Contractor subsequently modified its bid price, proposing to complete the Project at a bid price (Base Bid and Add Alt. 1) of an amount not to exceed Eight Hundred Fifty Five Thousand and 00/100 Dollars (\$855,000.00); and

WHEREAS, the Commissioner has recommended that the contract be awarded to the Contractor as the lowest responsible bidder at its modified bid price (Base Bid and Add Alt. 1) of an amount not to exceed Eight Hundred Fifty Five Thousand and 00/100 Dollars (\$855,000.00); and

WHEREAS, the Town Board desires to authorize the award of a contract to the Contractor as recommended by this Commissioner.

NOW, THEREFORE, BE IT

RESOLVED that the bid submitted by Aventura for the completion of the Project be and hereby is rejected for the reasons stated in this resolution; and be it further

RESOLVED that a contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its modified bid price (Base Bid and Add Alt. 1) of Eight Hundred Fifty-Five Thousand and 00/100 Dollars (\$855,000.00), as more particularly set forth in an agreement which will be filed in the Office of the Town Clerk (the "Award"); and be it further

RESOLVED that the Supervisor is hereby authorized to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of duly executed contract and certified claims therefor.
