RESOLUTION NO. 344-2015

A RESOLUTION AUTHORIZING THE AWARD OF A BID FOR IMPROVEMENTS TO THE SANITARY LIFT STATION AT WHITNEY POND PARK, MANHASSET, NEW YORK, DPW PROJECT NO. 15-03.

WHEREAS, the Town Clerk solicited bids for improvements to the sanitary lift station at Whitney Pond Park, Manhasset, New York, DPW Project No. 15-03 (the "Project"); and

WHEREAS, bids in response to the solicitation (the "Bids") were received and were opened, which Bids are as follows; and

WHEREAS, after a review of the bids, the Commissioner of Public Works (the “Commissioner”) has recommended that the contract for the Project be awarded to Bensin Contracting, Inc., 652 Union Avenue, Holtsville, New York 11742 (the “Contractor”) as the lowest responsible bidder at its bid price of One Hundred Twenty-Nine Thousand Three Hundred and 00/100 Dollars (\$129,300.00) (the “Award”); and

WHEREAS, the Town Board desires to authorize the Award to the Contractor as recommended by the Commissioner.

NOW, THEREFORE, BE IT

RESOLVED that a contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its bid price of One Hundred Twenty-Nine Thousand Three Hundred and 00/100 Dollars (\$129,300.00) as more particularly set forth in an agreement which will be filed in the Office of the Town Clerk; and be it further

RESOLVED that the Supervisor is hereby authorized to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of duly executed contract and certified claims therefor.
