A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH PRECISION INTEGRATORS, LLC FOR A FEASIBILITY STUDY CONCERNING WIRELESS CONNECTION BETWEEN TOWN HALL, PUBLIC WORKS, AND THE YES WE CAN COMMUNITY CENTER (TNH114-2014).

WHEREAS, the Department of Information Technology and Telecommunications (the "Department") requires the services of a firm to perform a feasibility study and design work pertaining to creating a redundant wireless connection between Town Hall, the Department of Public Works, and the North Hempstead "Yes We Can" Community Center (the "Services"); and

WHEREAS, the Commissioner of the Department (the "Commissioner") has recommended that the Town enter into a professional services agreement with Precision Integrators LLC, 130 New Road, Suite J2, Parsippany, New Jersey 07054 to provide the Services, in consideration of an amount not to exceed Seven Thousand Three Hundred and 00/100 Dollars (\$7,300.00) (the "Agreement"); and

WHEREAS, this Board finds it to be in the best interest of the Town to authorize the Agreement.

NOW, THEREFORE, BE IT

RESOLVED that the Agreement be and hereby is authorized; and be it further

RESOLVED that the Supervisor be and hereby is authorized and directed to execute the Agreement on behalf of the Town, which Agreement shall be on file with the Office of the Town Clerk, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney be and hereby is authorized and directed to negotiate and oversee the execution of the Agreement, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Comptroller be and hereby is authorized and directed to pay the costs of the Services upon receipt of the duly executed Agreement and certified claims therefore.
