2009 - 2010 TAX COLLECTION SCHEDULE**

October 1, 2009	First-half 2009 – 2010 School Tax due
November 10, 2009	Last day to pay School Tax without penalty
January 1, 2010	First-half 2010 General Tax due
February 10, 2010	Last day to pay General Tax without penalty
April 1, 2010	Second-half 2009 – 2010 School Tax due
May 10, 2010	Last day to pay School Tax without penalty
July 1, 2010	Second-half 2010 General Tax due
August 10, 2010	Last day to pay General Tax without penalty

When the 10th falls on a weekend or holiday, the last day to pay without penalty is the following business day. Note: The Tax Office will be closed for Election Day on Tuesday November 3rd and for Veteran's Day on Wednesday November 11th.
