2011 - 2012 TAX COLLECTION SCHEDULE**

October 1, 2011	First-half 2011 – 2012 School Tax due
November 10, 2011	Last day to pay School Tax without penalty
January 1, 2012	First-half 2012 General Tax due
February 10, 2012	Last day to pay General Tax without penalty
April 1, 2012	Second-half 2011 – 2012 School Tax due
May 10, 2012	Last day to pay School Tax without penalty
July 1, 2012	Second-half 2012 General Tax due
August 10, 2012	Last day to pay General Tax without penalty

When the 10th falls on a weekend or holiday, the last day to pay without penalty is the following business day. Note: The Tax Office will be closed for Election Day on Tuesday November 8th 2011 and for Veteran's Day on Friday November 11th 2011.
