



SUPERVISOR BOSWORTH: Good morning, everybody. If you could please rise for the pledge. (Pledge of Allegiance was recited.)

SUPERVISOR BOSWORTH: So this is a short meeting, at least the first part of it. Mr. Wink, if you could please call the meeting to order.

MR. WINK: Town of North Hempstead board meeting, Wednesday, December 6, 2017. Councilwoman DeGiorgio.

SUPERVISOR BOSWORTH: Here. So following our Town Board procedure, we will open the meeting with comments from the public on any matters that are not on the agenda. 12-06-17 Town of North Hempstead Town Board Meeting I don't know, Mr. Wink, if you have any cards.

MR. WINK: We do. We have two cards.

SUPERVISOR BOSWORTH: Okay. I'd just like to note that Councilwoman Russell has joined us.

(Whereupon, the public comment portion of the agenda was off the record.)

(Whereupon, the Town Board meeting agenda resumed.)

SUPERVISOR BOSWORTH: Mr. Wink, if you would please begin today's agenda

MR. WINK: Public Hearings: Item 1: A public hearing to consider the adoption of a local law amending Chapter 51 of the Town Code of the Town of North Hempstead entitled taxation.

SUPERVISOR BOSWORTH: So I'd like to acknowledge Peter Gong is with us today, and I know that it's because of this law that we're about to discuss. Thank you for being here, and Peter is a member of Veterans Advisory Committee. So thank you for all that you do on behalf of our veterans. So as I mentioned at the set date for this item, the Cold War Veterans Bill 6510 provided a ten-year property tax exemption to veterans who served on active duty in the United States Armed Forces during the Cold War. Assemblyman Tony D'Urso proposed to end the term limit and extend the exemption as long as the qualified veteran remains in their homes. This bill

has been passed by the Assembly and the Senate and signed by the Governor. So we here at the Town are now able to adopt a local resolution to end the term limit and that is what today's resolution will do. So it will extend it as long as the qualified veteran remains in his or her home. I will say that when I inquired as to the Council members about this, everyone's response was so enthusiastic, so this is a Town Board that is very much supportive of our veterans, and so I'm looking forward to doing this. So right now, is there anybody from the public that would like to speak regarding this resolution?

Supervisor Bosworth offered the following resolution and moved its adoption, which resolution was declared adopted after a poll of the members of this Board:

**RESOLUTION NO. 662 - 2017**

**A PUBLIC HEARING TO CONSIDER THE ADOPTION OF A LOCAL LAW AMENDING CHAPTER 51 OF THE TOWN CODE OF THE TOWN OF NORTH HEMPSTEAD ENTITLED "TAXATION."**

**WHEREAS**, the Town Board, as the legislative body of the Town of North Hempstead, is empowered to amend the Town Code pursuant to the provisions of Article 9 of the New York State Constitution, the Town Law, and the Municipal Home Rule Law; and

**WHEREAS**, a proposed Local Law has been prepared, pursuant to enabling legislation, to amend the Town Code by the adoption of a Local Law amending Chapter 51 of the Town Code entitled "Taxation" in order to amend the effectiveness of the partial real property tax exemption for qualified Cold War veterans so that it extends for as long as a qualified owner of the property, as defined by Chapter 51, remains a qualified owner; and

**WHEREAS**, the proposed Local Law, in final form, has been on the desks or tables of all the members of the Town Board for seven calendar days, exclusive of Sunday; and

**WHEREAS**, due notice has been heretofore given of a public hearing to be held on the 6th day of December, 2017, concerning the adoption of the proposed Local Law, which Local Law was available for viewing by the public on the Town's website and during regular business hours in the Office of the Town Clerk; and

**WHEREAS**, the Town Board carefully considered the proposed Local Law during the seven-day period, conducted a public hearing on December 6, 2017, with respect to said Local Law, and has afforded all interested persons an opportunity to be heard at the public hearing; and

**WHEREAS**, this Board deems it in the public interest to adopt the proposed Local Law, to be effective immediately upon filing with the Secretary of State of the State of New York (the "Secretary of State").

**NOW, THEREFORE, BE IT**

**RESOLVED** that Local Law No. 10 of 2017 be and it hereby is adopted, which Local Law reads as follows:

**TOWN OF NORTH HEMPSTEAD**

**LOCAL LAW NO. 10 OF 2017**

**A LOCAL LAW AMENDING CHAPTER 51 OF THE TOWN CODE, ENTITLED "TAXATION."**

Section 1. Legislative Intent.

Section 458-b of the Real Property Tax Law of the State of New York authorized local

governments to adopt local laws providing a partial exemption from real property taxes for a period of ten years for real property owned by persons classified as Cold War Veterans. Section 458-b was recently amended to provide local governments the option of continuing to provide the partial exemption for qualified owners for as long as they remain qualified owners, without regard to the previous ten year limitation. The purpose of this local law is to amend Article VI of Chapter 51 of the Town Code entitled "Taxation" in order to amend the effectiveness of the partial real property tax exemption for qualified Cold War veterans so that it extends for as long as a qualified owner of the property, as defined by Chapter 51, remains a qualified owner.

## Section 2.

Article VI of Chapter 51 of the Town Code entitled "Exemption for Cold War Veterans" is hereby amended as follows:

Article VI: Exemption for Cold War Veterans.

### §51-23 Definitions.

For the purposes of this article, the following definitions shall apply:

#### **ACTIVE DUTY**

Full-time duty in the United States Armed Forces, other than active duty for training.

#### **ARMED FORCES**

The United States Army, Navy, Marine Corps, Air Force, and Coast Guard.

#### **COLD WAR VETERAN**

A person, male or female, who served on active duty in the United States Armed Forces during the time period from September 2, 1945, to December 26, 1991, and was discharged or released therefrom under honorable conditions.

#### **LATEST CLASS RATIO**

The latest final class ratio established by the state board pursuant to Title 1 of Article 12 of this chapter for use in a special assessing unit as defined in §1801 of the Real Property Tax Law of the State of New York.

#### **LATEST STATE EQUALIZATION RATE**

The latest final equalization rate established by the state board pursuant to Article 12 of the Real

Property Tax Law of the State of New York.

### **QUALIFIED OWNER**

A Cold War veteran, the spouse of a Cold War veteran, or the unremarried surviving spouse of a deceased Cold War veteran. Where property is owned by more than one qualified owner, the exemption to which each is entitled may be combined. Where a veteran is also the unremarried surviving spouse of a veteran, such person may also receive any exemption to which the deceased spouse was entitled.

### **QUALIFIED RESIDENTIAL REAL PROPERTY**

Property owned by a qualified owner which is used exclusively for residential purposes; provided, however, that in the event that any portion of such property is not used exclusively for residential purposes, but is used for other purposes, such portion shall be subject to taxation, and only the remaining portion used exclusively for residential purposes shall be subject to the exemption provided by this article. Such property shall be the primary residence of the Cold War veteran or the unremarried surviving spouse of a Cold War veteran, unless the Cold War veteran or unremarried surviving spouse is absent from the property due to medical reasons or institutionalization.

### **SERVICE CONNECTED**

With respect to disability or death, that such disability was incurred or aggravated, or that the death resulted from a disability incurred or aggravated, in the line of duty on active military, naval or air service.

§51-24 Statutory authority.

Pursuant to §458-b of the Real Property Tax Law of the State of New York, the Town Board of the Town of North Hempstead, after due consideration, has provided for a partial real property tax exemption for qualified Cold War veterans, as specified in this article.

§51-25 Exemption granted.

Qualified real property owned by a Cold War veteran or an otherwise qualified owner shall be exempt from taxation to the extent of 15% of the assessed value of such property; provided, however, that such exemption shall not exceed \$12,000 or the product of \$12,000 multiplied by the latest state equalization rate of the assessing unit, or, in the case of a special assessing unit, the latest class ratio, whichever is less.

§51-26 Additional exemption.

In addition to the exemption provided by § 51-25 of this chapter, where the Cold War veteran received a compensation rating from the United States Veterans Affairs or from the United States

Department of Defense because of a service-connected disability, qualifying residential real property shall be exempt from taxation by the Town of North Hempstead to the extent of the product of the assessed value of such property, multiplied by 50% of the Cold War veteran disability rating; provided, however, that such exemption shall not exceed \$40,000, or the product of \$40,000 multiplied by the latest state equalization rate for the Town of North Hempstead, whichever is less.

§51-27 Limitations; application for exemption.

A. If a Cold War veteran receives the exemption under §458 or §458-a of the Real Property Tax Law of the State of New York, the Cold War veteran shall not be eligible to receive the exemption under this Article.

B. The exemption provided by §51-25 of this Chapter shall continue for as long as the qualified owner(s) of qualified residential real property remains a qualified owner(s), without regard to the ten year limitation set forth in §458-b, Subsection (2)(c)(iii) of the Real Property Tax Law of the State of New York.[be granted for a period of ten years. The commencement of such ten year period shall be governed pursuant to this paragraph. Where a qualified owner owns qualifying residential real property on the effective date of this local law, such ten year period shall be measured from the assessment roll prepared pursuant to the first taxable status date occurring on or after the effective date of this local law. Where a qualified owner does not own qualifying residential real property on the effective date of this local law, such ten year period shall be measured from the assessment roll prepared pursuant to the first taxable status date occurring at least sixty days after the date of purchase of qualifying residential real property; provided, however, that should the veteran apply for and be granted an exemption on the assessment roll prepared pursuant to a taxable status date occurring within sixty days after the date of purchase of residential real property, such ten year period shall be measured from the first assessment roll in which the exemption occurs. If, before the expiration of such ten year period, such exempt property is sold and replaced with other residential real property, such exemption may be granted pursuant to the above provisions for the unexpired portion of the ten-year exemption period.]

C. Application for exemption shall be made by the owner, or all of the owners, of the property on a form prescribed by the state board. The owner or owners shall file the completed form in the assessor's office on or before the first appropriate taxable status date. The exemption shall continue in full force and effect for all appropriate subsequent tax years and the owner or owners of the property shall not be required to refile each year. Applicants shall be required to refile on or before the appropriate taxable status date if the percentage of disability percentage increases or decreases or may refile if other changes have occurred which affect qualification for an increased or decreased amount of exemption. Any applicant convicted of willfully making any false statement in the application for such exemption shall be subject to the penalties prescribed in the New York State Penal Law.

§51-28 Date for timely filing of application.

Notwithstanding any other provision of law, applications for the exemption authorized pursuant to this article shall be considered timely filed if they are filed on or before the 15th day of March of the appropriate year.

§51-29 When effective.

This article shall take effect immediately upon filing with the Secretary of State of the State of New York.

Section 3.

This Local Law shall take effect immediately upon filing with the Secretary of State and shall apply to all recipients of the exemption provided by this Article as of the effective date of this local law and any future applications for the exemption.

**RESOLVED** that the Town Clerk be and hereby is authorized and directed, in the manner required by law, to file a copy of said Local Law with the Secretary of State, and to publish a notice of adoption of said Local Law, which notice shall be in substantially the following form:

**RESOLUTION NO. 663 -2017**

**A RESOLUTION ESTABLISHING THE TOWN OF NORTH HEMPSTEAD TREE ADVISORY BOARD.**

WHEREAS, the Arbor Day Foundation partners with national and state forestry services to sponsor a recognition program under which towns and cities can receive recognition as a Tree City USA; and

WHEREAS, the designation of the Town of North Hempstead ("Town") as a Tree City USA would acknowledge the importance the Town places on the environment and the trees of the Town and will afford the Town access to important sources of grant funding; and

WHEREAS, recognition of the Town as a Tree City USA requires the existence of a tree board or department; and

WHEREAS, the Town Board previously served as the tree board for purposes of the Town's Tree City USA designation; and

WHEREAS, the Town Board now wishes to establish a Town of North Hempstead Tree Advisory Board to act in an advisory capacity to the Town Board, in order to assist and advise the Town Board on matters relating to the preservation, planting and removal of trees in the Town.

NOW, THEREFORE, BE IT

RESOLVED, that the Town of North Hempstead Tree Advisory Board (the "Board") be and hereby is established pursuant to the provisions and requirements as provided herein; and be it further

RESOLVED, that the Board shall be comprised of four to ten (4-10) members, who shall serve at the pleasure of the Town Supervisor; and be it further

RESOLVED, that Committee members shall include the Town Horticulturist and representatives from the Supervisor's Office, the Department of Parks and Recreation, the Building Department, the Highway Superintendent, and such other members as the Supervisor shall appoint; and be it further

RESOLVED, that the powers and duties of the Committee shall be as follows:

- 1) Make recommendations concerning new or amended legislation related to the protection and enhancement of the trees of the Town;
- 2) Identify varieties and tree species suitable for planting in the Town;
- 3) Compile an inventory of street trees, landmark trees and other significant trees in the Town;
- 4) Make recommendations concerning the development of a community forestry work plan addressing the planting, maintenance and removal of trees;
- 5) Promote programs and projects that protect and improve Town trees and increase public awareness of the economic and environmental benefits of trees;

- 6) Work with the Grants Coordinator to identify available sources of funds to preserve and enhance the urban forest;
  - 7) Perform such other duties as the Supervisor may assign to the Board; and
  - 8) Continue the Town's participation in the National Arbor Day Foundation's Tree City USA program
- ; and be it further

**RESOLVED**, that the Board shall designate one of its members as Chairperson. The Board shall meet at least quarterly at a time and place designated by the Chairperson and shall adopt rules and procedures to govern its meetings.


