RESOLUTION NO. 115 - 2022

A RESOLUTION AUTHORIZING THE AWARD OF A BID FOR REHABILITATION OF GROUNDWATER EXTRACTION AND TREATMENT SYSTEM, PROJECT NO. SW02-20 (TNH277-2021).

WHEREAS, the Town of North Hempstead Department of Solid Waste Management solicited bids for Rehabilitation of Groundwater Extraction and Treatment System, Project No. SW02-20, Bid No. TNH277-2021 (the "Project"); and

WHEREAS, bids in response to the solicitation (the "Bids") were received and were opened, which Bids are as follows; and

WHEREAS, after a review of the bids, the Commissioner of the Town's Department of Solid Waste Management (the "Commissioner") has recommended that the contract for the Project be awarded to Bensin Contracting, Inc., 652 Union Avenue, Holtsville, NY 11742 (the "Contractor") as the lowest responsible bidder at its base bid price of One Hundred Forty-Nine Thousand Five Hundred and 00/100 Dollars (\$149,500.00) and valve allowance of Three Thousand Four Hundred Twenty-Five and 00/100 Dollars (\$3,425.00) per valve as necessary; and

WHEREAS, the Town Board desires to authorize the award of a contract to the Contractor as recommended by this Commissioner.

NOW, THEREFORE, BE IT

RESOLVED that a Contract for the Project is hereby awarded to the Contractor, as the lowest responsible bidder, at its bid price of One Hundred Forty-Nine Thousand Five Hundred and 00/100 Dollars (\$149,500.00) and valve allowance of Three Thousand Four Hundred Twenty-Five and 00/100 Dollars (\$3,425.00) per valve as necessary, as more particularly set forth in an agreement which will be filed in the Office of the Town Clerk (the "Award"); and be it further

RESOLVED that the Supervisor is hereby authorized and directed to execute the contract documents, and to take such other action as may be necessary to effectuate the foregoing; and be it further

RESOLVED that the Office of the Town Attorney is hereby authorized and directed to supervise the execution of the contract documents to effectuate the Award; and be it further

RESOLVED that the Comptroller is hereby authorized and directed to pay the cost thereof upon receipt of a duly executed contract and certified claims therefor.
